


ELI Renters Face the Most Severe Affordable **Housing Shortage**



Renter Households and Affordable & Available Rental Homes, 2016



Opportunity Starts at Home Legislative Priorities

 Dramatically expand rental assistance to bridge the gap between rent and income

 Dramatically expand the supply of housing affordable to the lowestincome renters

 Create a new national program that provides temporary financial assistance to help cover the rent for households experiencing unexpected economic shocks

If Enacted...



- Cut poverty rate by 2.9% (Booker) or 2.4% (Harris); the current rate is 13.5%.
- Lift 9.4M (Booker) or 7.8M (Harris) people out of poverty.
- One of the most effective ways of addressing poverty, because housing is typically an individual's largest cost.
- Help address racial inequity because people of color are disproportionately harmed by the housing crisis and homelessness.

Why Approach #2



It's what RESULTS does. It makes RESULTS unique and effective: We cultivate motivation, give people agency as change makers, put people in relationship with each other. We help people become the change agents and people they always dreamed of becoming.

Why Approach #2



"...we have to stop thinking about activism as costly...we have to think about it more as value ... You know, how do you make people feel like they're part of something that has purpose. If I look at some of the polling data and people's disaffection from politics in general, I think people are hungry for meaningful experiences and meaningful ways to engage in public life. And there are a lot of grassroots organizations out there, but there aren't a lot of grassroots organizations that invite people into a meaningful experience through which they can have a voice over outcomes they really care about. So. I think, first is understanding that value proposition and being really clear about it."




