Protect SNAP in the next Farm Bill

Everyone deserves to live healthier lives and have access to nutritious foods. An integral tool to ensure that all Americans have access to basic nutrition is the **Supplemental** Nutrition Assistance Program (SNAP).

SNAP currently serves around 40 million people each month. Families with children, older Americans, and persons with disabilities account for nearly 90 percent of SNAP recipients. SNAP reduces poverty, improves community health, and bolsters local economies.

SNAP is reauthorized every five years in the Farm Bill. House and Senate leaders have released plans for a new Farm Bill. The Senate proposal reflects the priorities needed to reduce hunger in America; the House version does not.

In particular, the Senate protects the 2018 bipartisan improvements to the Thrify Food Plan (TFP). The TFP is used to calculate the amount of SNAP benefits a familiy needs to sustain a frugal but healthy diet. In 2021, the TFP was updated to refelct current nutrition science and food costs. It resulted in the first TFP-based increase in SNAP benefits in almost 50 years. The House proposal would undo this improvement, resulting in a \$30 billion cut in SNAP benefits over the next decade (see chart). This cut impacts every person receiving SNAP and will increase hunger in America.

On a positive note, both proposals appear to lift the lifetime ban on SNAP benefits for those

All SNAP Participants Would Face Benefit Cut **Under House Agriculture Committee Chair Thompson's Thrifty Food Plan Proposal**

This proposal would reportedly cut SNAP by roughly \$30 billion over the next decade by restricting future updates to the Thrifty Food Plan to only account for inflation, ignoring other factors like changing dietary guidance that impact the cost of a healthy diet. Groups affected over 2027-2033 would include:



Children: \$18 billion of the cut would affect households with children, which in a typical month would include nearly 17 million children.



Preschool-age children: \$9 billion of the cut would affect households with young children (under age 5), which in a typical tildren.



Older adults: \$5 billion of the cut would affect households with older adults, which in a typical month would include more than 6 million individuals aged 60 or older.



People with disabilities: \$6 billion of the cut would affect households with people with disabilities, including more than 4 million such disabled individuals in a typical month.



Working families: \$11 billion of the cut would affect households with earnings.

convicted of a drug offense. This is welcomed, long-overdue change.

RESULTS strongly urges Congress to protect and strengthen SNAP in new Farm Bill. They should preserve the 2018 changes to the TFP, expand SNAP access to those susceptible to hunger but not currently eligible, reduce onoerous work reporting requirements, and expandi food choice so SNAP recipients can purchase hot, prepared meals at food retialers.

- 3. I am writing to urge you to support of SNAP, the last line of defense against hunger in the United States. In 2022, SNAP helped 3.7 million people lift themselves from poverty.
- 4. Most SNAP recipients who are able to work, do work. Of the approximately 40 million people receiving SNAP each month, nearly 90 percent are families with children, older Americans, and persons with disabilities.
- 5. Despite its success, SNAP benefits average less than \$7 per day per person. Without recent improvements to the Thrifty Food Plan (TFP), that amount would be lower.
- 6. It is imperative that the new Farm Bill does not make hunger in America worse. No Farm Bill this year is better than a bad Farm Bill.
- Will you please speak to House Agriculture Chair Thompson and Ranking Member Scott / Senate Agriculture Chair Stabenow and Ranking Member Boozman and urge them to protect and strengthen SNAP in the new Farm Bill by:
 - Protecting the 2018 bipartisan improvements to the Thrifty Food Plan
 - Ending the lifetime SNAP ban for those with drug convictions
 - Ending onerous work reporting requirements
 - Expanding grocery food choice to include hot foods
