# Protect SNAP in the next Farm Bill

Everyone deserves a healthier life and access to nutritious foods. An integral tool for ensuring that all Americans have access to basic nutrition is the Supplemental Nutrition Assistance Program (SNAP).

SNAP currently serves over 42 million people each month. New U.S. Census data shows that in 2023, SNAP kept 3.4 million people from falling into poverty. Families with children, older Americans, and persons with disabilities account for nearly 90 percent of SNAP recipients. SNAP reduces poverty, improves community health, and bolsters local economies. It must be protected and strengthened.

As Congress works on a new Farm Bill, some leaders want to cut SNAP benefits by \$30 billion over the next decade. This will result in more hunger and hardship for millions.

In particular, the House proposal would undo the 2018 bipartisan improvements to the Thrifty Food Plan (TFP). The TFP calculates the amount of SNAP benefits a family needs to sustain a frugal but healthy diet. In 2021, the TFP was updated to reflect current nutrition science and

#### All SNAP Participants Would Face Benefit Cut Under House Agriculture Committee Chair Thompson's Thrifty Food Plan Proposal

This proposal would reportedly cut SNAP by roughly \$30 billion over the next decade by restricting future updates to the Thrifty Food Plan to only account for inflation, ignoring other factors like changing dietary guidance that impact the cost of a healthy diet. Groups affected over 2027-2033 would include:



**Children:** \$18 billion of the cut would affect households with children, which in a typical month would include nearly 17 million children.



**Preschool-age children:** \$9 billion of the cut would affect households with young children (under age 5), which in a typical month would include about 5 million young children.



**Older adults:** \$5 billion of the cut would affect households with older adults, which in a typical month would include more than 6 million individuals aged 60 or older.



**People with disabilities:** \$6 billion of the cut would affect households with people with disabilities, including more than 4 million such disabled individuals in a typical month.



**Working families:** \$11 billion of the cut would affect households with earnings.

food costs. It resulted in the first TFP-based increase in SNAP benefits in almost 50 years.

Undoing this change would result in a \$30 billion cut in SNAP benefits over the next decade (see chart for more details). This cut impacts every person receiving SNAP and will increase hunger in America.

Congress must protect and strengthen SNAP in a new Farm Bill. They should preserve the 2018 changes to the TFP, expand eligiblity to others susceptible to hunger (e.g., those with felony convictions who have served their time), reduce onerous work reporting requirements, and expand food choice so SNAP recipients can purchase hot, prepared meals at food retailers.

# Write letters to Congress about protecting SNAP

Use the talking points below to write letters to your representative and senators today urging them to protect and strengthen SNAP in the new Farm Bill. Consider organizing a group to write letters together. Invite RESULTS group members, Action Network members, and others who care about these issues to write and submit their own letters to members of Congress. ## **Subject: Protect the Supplemental Nutrition Assistance Program (SNAP)**

- 1. Tell your representative/senator that Congress is overdue in passing a new Farm Bill which governs farming and food policies in the U.S., including the Supplemental Nutrition Assistance Program (SNAP).
- 2. Share that according to USDA data, last year, 6.8 million households in America experienced "very low food security" at some point.
- 3. Remind them that SNAP helps over 40 million Americans put food on the table each month. Most recipients are working families with children, elderly persons, and people with disabilities.
- 4. Explain that unfortunately, SNAP continues to be under attack by lawmakers who want harmful changes that will cut benefits, limit access, and restrict choice.
- 5. Tell them that, as Congress considers a new Farm Bill, lawmakers must reject efforts to cut or restrict SNAP. Instead, they must work to make it stronger. They must expand access and increase benefits for vulnerable populations.
- 6. Ask your representative/senator to urge House Agriculture Committee Chair Thompson and Ranking Member Scott / Senate Agriculture Committee Chair Stabenow and Ranking Member Boozman to protect and strengthen SNAP in the new Farm Bill.
