

FY24 Dear Colleague Letter <u>Scorecard</u>



End TB Now Act S.288, H.R.1776



- 1. Requires the U.S. to establish bold goals for reaching the most vulnerable populations
- 2. Strengthens U.S. bilateral coordination to develop comprehensive global TB response
- 3. Catalyzes support for TB research and development (R&D)
- 4. Improves the capacity of countries and affected communities with high burdens of TB
- 5. Requires annual reporting to Congress on U.S. TB activities and their impact
- 6. Evaluates the performance of TB programs that are supported by U.S.



READ Act S.41, H.R.681



Calls for USAID to:

- 1. Develop comprehensive strategy that improves educational opportunities and addresses barriers to attendance, retention, completion, especially for girls;
- 2. Ensure education services for children affected by conflict and other emergencies;
- 3. Coordinate U.S. government efforts to efficiently and effectively manage resources;
- 4. Work with countries to strengthen systems in order to build long-term sustainability;
- 5. Engage with key partners including other donors, civil society and multilateral initiatives, including the Global Partnership for Education, for greatest impact
- 6. Require specific indicators and objectives with which to measure progress;
- 7. Improve the transparency and accountability of our basic education programs, ensuring taxpayer dollars have the most impact for children worldwide.



2023 Global Policy Priorities



What's next?

1. Congress will continue work on budget proposal following input on FY24 Appropriations. SFOPS will draft a spending bill either with or without guidance on budget numbers. There may be opportunities to ask members to speak to SFOPS

- The End TB Now Act (H.R. 1776/ S. 288)

About The MoonCatcher Project

- MCP removes barriers related to menstruation.
- MCP provides the knowledge and supplies needed to manage menstruation with dignity and confidence, thereby increasing a girl's chance of staying in school, avoiding early marriage, and enjoying greater economic security.
- Location: Uganda, Malawi, Kenya
- **Grant Amount:** \$43,000
- Areas of Impact: Economic Sustainability, Education, Gender Equality

Advocacy Action

Requesting co-sponsorship of the READ Act Reauthorization (H.R. 681/ S.41)





Engage

There is a phenomenon called "learning poverty," and it targets the futures of children. Children who experience learning poverty cannot read or comprehend simple text by 10 years old.





State the problem

According to the World Bank, roughly 57% of children in low- and middle-income countries experienced learning poverty in 2019. Thanks in part to the COVID-19 pandemic, that rate has increased to a stunning 70%.





Inform on solutions

The RFAD Act of 2017 made a difference in the lives of millions of young people and needs to be reauthorized in 2023. The bill calls on the U.S. to update its foundational literacy and numeracy strategy. It also calls for robust monitoring and evaluation.





Call to action

Children around the world need reading and numeracy skills for success and a bright future.
