

Global Fund to Fight AIDS, Tuberculosis and Malaria

RESULTS requests \$1.53 billion for the Global Fund to Fight AIDS, Tuberculosis and Malaria in FY27.

At the height of the AIDS crisis, the world came together to fight back. Governments and donors pooled resources to create the Global Fund to Fight AIDS, Tuberculosis and Malaria (Global Fund). Since then, the U.S. has provided one-third of the Global Fund's financial resources, thanks to longstanding bipartisan commitment from Congress.

This international partnership has helped save 70 million lives, reducing the death rate of the three diseases by 63 percent. Since it was founded, the Global Fund has transformed the world's response to these three leading killers and drivers of poverty. In 2024 alone, the Global Fund's work resulted in 25.6 million people on HIV antiretroviral therapy, 7.4 million treated for tuberculosis (TB), and 162 million mosquito nets distributed.

The Global Fund is a locally-driven, country-led partnership that prioritizes human rights. The partnership stretches the impact of every dollar, bringing together the expertise of local governments, faith-based groups, the private sector, U.S. bilateral health programs, and communities directly affected by AIDS, TB, and malaria.

The Trump Administration has pledged \$4.6 billion to the Global Fund over three years. Congress must work together to make good on this pledge, and ensure all previously appropriated funds are delivered as intended.

U.S. leadership is critical to the Global Fund

Over the last two decades, bipartisan congressional support for the Global Fund has inspired billions of dollars in commitments from other governments. That support can now help power the next phase of this partnership's impact.

By law, every dollar committed by the U.S. to the Global Fund must be matched by \$2 from other donors. At the 8th replenishment last fall, the U.S. recommitted to the 1:2 match, which spurs other donors to come forward. Securing the full pledged amount in FY27 will demonstrate the U.S.'s continued commitment to ending these diseases. Delivering the U.S. pledge as new funding, not double counting previously appropriated funds, will be essential to sustain progress and protect millions from preventable illness and death.

Why funding matters

The Global Fund represents one of the world’s most effective mechanisms for saving lives. The U.S. must deliver on the Trump Administration’s multiyear pledge. In this new replenishment cycle, the Global Fund has a bold plan to:

- Save 23 million more lives
- Stop 400 million new infections from HIV, tuberculosis (TB), and malaria
- Unlock \$9.8 billion in savings, by pooling demand for lifesaving products

Scaling up innovation: The Global Fund makes sure that breakthroughs in science lead to real impact. Thanks to the partnership, innovative AI-enabled portable chest x-ray machines to screen for TB are in use. Brand new injectable prevention for HIV is ready to roll out. Kids are sleeping under next-generation mosquito nets.

Partnership model: Central to the Global Fund’s success is its structure as a partnership. It pools funding from governments, philanthropies, and the private sector and prioritizes grants based on need. Local governments, faith groups, companies, and communities directly affected by AIDS, TB, and malaria all work together to design and lead the work.

Market shaping: The Global Fund makes health care more efficient and effective. The partnership strengthens supply chains and supports private sector innovation. It also provides bulk guarantees for manufacturers and drives down costs. In recent years the Global Fund helped secure price reductions of 20 to 50 percent for critical health supplies.

Localization: Local country partners have always designed and carried out Global Fund programming. The central organization operates with only a lean secretariat. Countries and communities are at the center of the strategy, operations, and decision-making. This helps Global Fund resources better reach people and groups who are too often excluded.
