Anti-Oppression 201: Structural Racism

In this intermediate-level workshop, we will move from self-focused, reflective learning to understanding how social structures are based on white privilege and stereotypes in the U.S. We will reflect on our identified biases and stereotypes that may contribute to practices contributing to structural racism. Ways in which these practices can be interrupted will be addressed. Race is a social construct based on power and hierarchy. We live in a society entrenched in this structure. There is no biological connection to race. Most of us categorize people on site using our implicit biases and stereotypes.

Anti-Oppression 301: Oppression: The Missing Perspectives

This workshop will culminate in self-reflection and identifying race and class biases, including marginalized and oppressed populations. Ways in which we can develop multicultural perspectives and interrupt the deleterious effects of racial and class status will be discussed. A brainstorming session will be included to develop the tools necessary to learn to adopt a multicultural perspective of others and the necessary insight into race and class and ways to counterbalance their effects on the lack of equity in the U.S.
